**Three Objections were received by RP to the PRAs,** as per regulation 36A (11) of CIRP Regulations, where any objection to inclusion or exclusion of a Prospective Resolution Applicant in the provisional list could have been made with supporting documents within 5 days from the date of issue of the List of PRAs to the Resolution Professional, i.e. 01-07-2024. The objections received has been considered by Resolution Professional and accordingly the list has been amended:

- 1. Objection regarding Krish Infrastructure Private Limited: This company is not the part of the Krrish Group which owns Jasmine Buildmart Private Limited presently. The promoters of Krish Infrastructure Private Limited, as mentioned in the above list, are different than the promoters of Jasmine Buildmart Private Limited, who have filed IPR Case against KRRISH long back.
- 2. Objection from SKEAL Enterprises Private Limited: Expression of Interest is in consortium with Sustainable Projects Private Limited and Aadi Best Consortium Private Limited and apprised about the change of promoters of Aadi Best Consortium Private Limited.
- 3. Objection regarding E Meditek Insurance Limited (Gopal Verma): Expression of Interest

(EOI) has been made by the association of homebuyers (with over 50 homebuyers as member of the association). The name of the association was approved after the last date to submit the detailed EOI and the change has been accordingly made. Considering, the approval in 3<sup>rd</sup> CoC meeting held on 31<sup>st</sup> May, 2024, the association of homebuyers were allowed to provide the name and remaining documents of the association after the due date.
